Examples and Qualification Criteria

Examples

Consumable Products:	Safety supplies, ice and water, small tools, office and cleaning supplies, equipment and tool repair, welding gases and rods, lumber and hardware
Site Materials & Equipment:	Equipment rentals, catering, light fabrication, concrete, aggregate, and rebar
Subcontracts & Services:	Insulation, fencing, tents, permanent buildings, piling, hydro excavation, HVAC, civil and road work, fireproofing, roofing and siding, fiber optic testing, heavy lift/heavy haul, NDE, environmental and sanitary services
Permanent Equipment & Materials:	Bulk electrical materials, cables, instrument construction materials, valves, flanges, pipe, steel, fabricated steel structures, pumps, compressors, vessels, and heat exchangers

Qualification Criteria

Depending on the specific need, CCZ JV evaluates a number of technical and commercial considerations, such as:

- Legal compliance
- Insurance and bonding
- Health, safety, and environmental statistics and programs
- Track record for past performance and current capabilities
- Financial strength
- Quality system and certifications
